REQUIREMENTS

- Assist Resource Leader Rock Engineering in specific functions
- Be able to assume technical responsibilities as laid out in the Modikwa role profile for Strata Control Officer
- Be able to perform panel and tunnel risk ratings
- Do short term projects and write technical reports
- Support mine safety programmes

WORK DESCRIPTION

The Strata Control Officer is responsible for assisting the Senior Rock Engineer with strata control issues in his area of responsibility. The role is responsible for conducting underground investigations on request, observe strata conditions and ensure rock engineering standards are complied with, as well as pro-actively identifying high risk areas. The incumbent also bares the responsibility of conducting panel and tunnel risk ratings on mine plans. In addition to this the incumbent is required to participate in short term (monthly), pre-planning meetings in conjunction with production and other technical services departments. The incumbent is also responsible to ensure timeous and accurate reporting of potential hazardous conditions underground to the Senior Rock Engineer.
