- Reclaim redundant electrical equipment
- Install/suspend/join cables i.e. prevent damage by moving TMM's
- Extend cables by means of a splice kit
- Replace light globes, fluorescent tubes and dispose off in an approved manner
- Connect or disconnect an electrical supply cable with a capacity of up to 11 KV
- Isolate and test electrical apparatus prior to commencing work
- Test earth leakage trips
- Stacking
- Repair/replace damaged or broken electrical items/parts
- Service and maintain all electrical equipment and machines
- Coordinate and supervise subordinates
- Do maintenance and breakdown duties as required;
- Perform Planned Maintenance duties
- Update and maintain maintenance systems;
- Sign off all daily check performed by self and subordinates
- Submit reports as required
