**Bokoni Platinum Mine** is an ARM owned mining operation situated on the eastern limb of the Bushveld Complex. This operation is planned to produce circa 400,000 oz per annum. Its project plan includes the construction of new decline shafts with combined capacity of 240,000 tons per month, a new concentrator plant, tailings storage facility and associated surface and underground infrastructure.

Applications are invited from suitably qualified and experienced persons for the position of **Miner**. The position will be based at Bokoni Platinum Mine at Atok (Fetakgomo Tubatse Local Municipality, Sekhukhune District Municipality in Limpopo.

### Miner (C2)

#### Purpose of the job

To effectively inspect and declare safe underground working areas, conduct vertical shaft examinations and lead barrel and structural repairs by ensuring safe working practices, continuous inspection of working areas and/or conditions, planning to achieve operational targets and monitoring the availability of resources. The miner has legal accountability for underground working areas in terms of the MHSA, will be required to contribute and assist the Engineering team with the execution of all the maintenance tasks. Most areas are in Care-and-Maintenance, but Ad-Hoc mining may occur whereby the position would also require the effectively operation of a stopping panel and/or development end in line with safe working practices and/or conditions.

#### Job Requirements:

- Grade 12 or equivalent.
- A minimum of one-year experience as a Crew Captain.
- Competent A&B certificate is a requirement.
- Blasting Certificate (DMRE/MQA Level 3).
- At least three years' experience in a mining environment.
- 2 Years experience as a Banksman/Onsetter can be advantageous.
- Experience with working at height (no phobia of heights).
- 2 Years experience at a vertical shaft environment.
- 2 Years experience at a decline shaft at a Hard rock operation.
- Literacy in English and numeracy.
