- Stop the belt/vibrator and remove bigger rocks in order to prevent blockages on the transfer chutes
- Stop the belts if there are any foreign objects that can cause damage to the be
- Remove obstructive objects for the belt to move freely
- Ensure that the oil level is at the limit on the glass gauge (power pack)
- Control and stop the leaks on the hydraulic systems and pipes
- Lubricate the grease nipples on a daily basis
- Report any deviations on the machine immediately to the supervisor
- Control the robot when the LHD is tipping
- Assist with the operation of the belts
