 faults, dykes and joints, etc. Geological mapping on correct depth plane and prepare structural model for geological
 valuation purposes.
- Generate ventilation plans indicating escape routes, fire escapes and all related features.
- Plot quarterly planning on a monthly basis and assist with the layout of life of mine plan, including annotation of workplace names and dates. Re-design mine layout where applicable.
