

- Interpret the approved logistics execution plans. Determine how logistics resources and processes must be utilised / applied to achieve the scheduling and execution objectives. Plan the office staff accordingly to meet business plan (rail and road plans).
- Resolve problems as they are encountered to ensure achievement against plan.
- Ensure executional plan is implemented with specific reference to road transport spillage and clean-up to ensure on-time delivery.
