- Drive safety within operations process in collaboration with field operators, issuing a work permit to artisans on a specific piece of equipment and upon completion of work, sign back the equipment in accordance with safety protocols.
- Contribute towards the process of troubleshooting by utilising control system tools and knowledge of operational dynamics to assist the operational and maintenance department with fault finding.
- Coordinate emergency response efforts. Activate emergency state.
- Escalate emergency according to emergency escalation procedures. Monitor emergency response effectiveness and progress. Log progress of emergency response.
- Provide ongoing status updates on emergency to relevant stakeholders.
- Escalate ineffective emergency response to relevant stakeholders.
