To control and monitor and execute the metallurgical beneficiation process plant in collaboration with field operators and artisans; to ensure that process runs efficiently and safely according to applicable procedures. Management of product quality (i.e. control different grades of ore from underground to surface plant). Including the management of product quality deviations according to acceptable procedures.

- Contribute towards the process of troubleshooting by utilising control system tools and knowledge of plant dynamics to assist the operational and maintenance department with fault finding.
