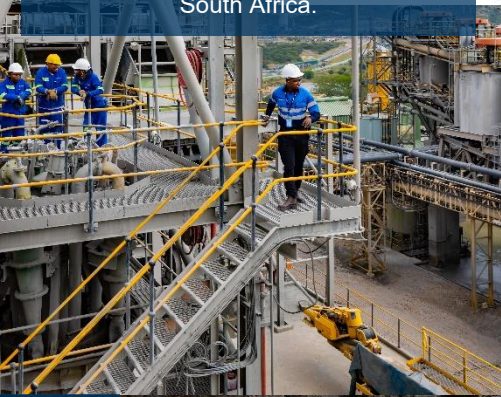


CAREER OPPORTUNITY
