- Optimise Face Mapping coverage by coordinating work output with own colleagues as well as the Mining and Rock Engineering Departments
- Print Daily Face Mapping reports, RIF/RIH reports, issue stop notes daily where applicable & communicate with relevant HODs.
- Assist/Coach miners underground with the identification of the "Top" and "Base" of the reef as well as geological anomalies.
- Waste clearance for off reef panels when back on reef.
- Plotting of Waste tags information on MicroStation
- Reef in foot clearance for reconciliation.
- Core receiving daily for the geologists where applicable.
- On request Take information on Camera Holes underground for Rock Engineering.
- On Request Help Survey Department with Measuring peg to Face distances month end.
