Applications are invited from suitably qualified and experienced persons for the position of Miner at Modikwa Platinum Mine South Two Shaft business unit. The incumbent will report to the Operations Supervisor – Mining.

REQUIREMENTS

- Grade 10 Numeracy.
- Blasting Ticket for Scheduled Mines.
- English literate.
- At least three to five years mining experience of which one year should be a Team Leader.
- Valid Medical Certificate (Red Ticket).
- Valid First Aid Certificate.
- Valid Code 8 driver's license.

DUTIES AND RESPONSIBILITIES

- Daily safety meetings.
- Ensuring Daily Quality Blast as called.
- Marking the face and supervising drilling procedure.
- Panel cleaning according to set standards and ensuring a safe working Area and Panel Support.
- Early Panel Examination, communicate planned targets to the stoping team, and ensure good employee relations. Address Sub Standard conditions and optimising material usage and reclamation. Handling and preparing explosives.
- Motivation, coaching, supervision and administration of the team.

WORK DESCRIPTION

The crew captain fulfils a shift role and has legal accountability with a 2.9.2 appointment in terms of the MHSA. The incumbent is responsible for the safe and effective blasting of stope panels and development ends. The incumbent bears the responsibility to supervise team activities and is required to ensure safe working practices, continuous inspection of stope panel and development end conditions, planning to achieve operational targets and monitoring the availability of resources. The incumbent is also expected to contribute and assist the panel team with execution of all daily panel tasks. The major responsibility of this role is to ensure the effective operation of stoping panels and development ends during a shift.
