- Support Sampling Controller in relieving duties. Assist Sampling Controller in managing team performance and resolve conflict. Act as team leader for sampling personnel.
- Assist in specialist projects and agreed services assigned and delivered, such as assisting to take samples and customer samples, adhoc sampling for metallurgical balances and or online analysers calibrations. Ensure fines, superfines and moisture samples are done correctly.
