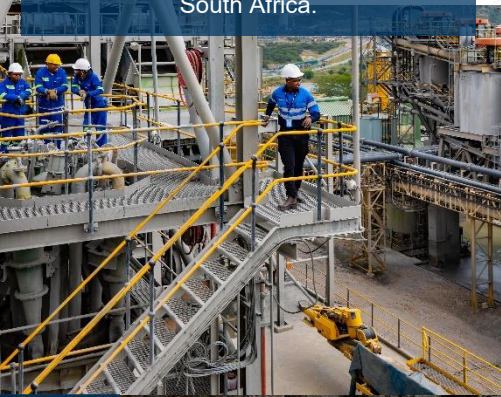


CAREER OPPORTUNITY
