PURPOSE OF THE JOB

The role holder will be required to co-ordinate and advise drivers related to the day to day picking of stock against valid picking slips. The role holder will be expected to work at underground stores as and when required.

- Should verify that the picking slip is properly filled in and authorised and that the correct product codes are used.
- Ensure adherence to safety standards, policies and procedures
- Ensure correct item is issued with regards to description and serial number where applicable.
- Ensure access control in the stores is maintained
- Report all stock discrepancies to supervisors immediately.
- Operation of PPE container as required
- Ensure that all picking slips are processed on ERP System daily and all issues have been properly accounted for and the stock has been adjusted accordingly.
- Resolves end-user complaints and answers inquiries.
- Process all manual requisitions/picking slips raised in the store immediately after issuing stock.
- To do stock transfer from one store to another.
- To pick transferred items from the main store to underground store
- To interact with the underground store issuers as required.
- Maintain Housekeeping in the warehouse at all times
